Aliansce Shopping Centers S.A. (Bovespa: ALSC3), a corporation registered as a publicly-held company by the Brazilian Securities and Exchange Commission ("CVM"), in category "A", headquartered at Rua Dias Ferreira No. 190, 3<sup>rd</sup> floor, in the city and state of Rio de Janeiro, enrolled with the corporate roll of taxpayers (CNPJ/MF) under No. 06.082.980/0001-03 ("Aliansce" or "Company"), pursuant to article 3 of CVM Instruction No. 358, of January 3, 2002, as amended, hereby announces to the market that the Extraordinary Shareholders Meeting held on this date ("Shareholders Meeting") approved the purchase of a 25.1% equity interest in Shopping Leblon, located in the city of Rio de Janeiro, in the state of Rio de Janeiro ("Acquisition"). The closing of the Acquisition is due to take place after the fulfillment of certain conditions precedent, including the approval by the Brazilian Antitrust Authority (CADE).

The approval of the acquisition by the Shareholders Meeting was a condition for the realization of the private capital increase, approved by the Company's Board of Directors on August 26<sup>th</sup>, 2016 ("<u>Capital Increase</u>"). The Company's shareholders which, on this date, hold common shares issued by the Company, will have right of preference in the subscription to the Capital Increase, in the proportion of their respective participations in the Company's capital. The preference rights may be exercised from September 14<sup>th</sup>, 2016 (including) to October 13<sup>th</sup>, 2016 (including), according to the terms set by the Notice to Shareholders, disclosed by the Company on September 12<sup>th</sup>, 2016.

The Company reaffirms its commitment to keep the shareholders and the market in general informed about any developments of this matter, as well as any other matters that are relevant to the market. For additional information, please contact the Investor Relations Department.
